The BIG Veganism in Education Conference

Call for presentations

The Vegan Society cordially invites speakers to the first ever vegan-inclusive education conference.

Context

Veganism is a philosophy and way of living which seeks to exclude—as far as is possible and practicable—all forms of exploitation of, and cruelty to, animals for food, clothing or any other purpose; and by extension, promotes the development and use of animal-free alternatives for the benefit of animals, humans and the environment. In dietary terms it denotes the practice of dispensing with all products derived wholly or partly from animals.¹

The vegan philosophy is not routinely taught in schools and many educational resources and activities perpetuate prejudice against other animals. We know from experience that vegan parents and pupils struggle to have their educational needs met.

Successful inclusive education requires school transformation and systems change. One key element is understanding existing structural, educational, and cultural challenges. Successful inclusion also requires the provision of inclusive education training, sustained support, and resources for all teachers and school leaders.²

International and European human rights provisions mandate respect for the right of parents to education and teaching that aligns with their own religious, moral, and philosophical convictions.

In the UK, veganism attracts protection under human rights law and ethical veganism is a protected characteristic for the purposes of the Equality Act 2010.

In addition, the Public Sector Equality Duty requires schools to eliminate discrimination, harassment and victimisation; advance equality of opportunity between persons who share a relevant protected characteristic and persons who don't and foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

Our conference asks:

What are the existing challenges to successful vegan-inclusive education?
